Expression of Interest

Expression of Interest are invited from *inhabitants of Beau Bassin and Rose Hill and the public* willing to occupy a stall at Beau Bassin Market, Da Patten Fair, Plaisance Fair or Chebel Fair.

INSTRUCTIONS TO APPLICANTS

1. Eligibility Criteria

Stalls in the fair / market will be allocated as per the following criteria:

1) The applicant shall:

- (i) a. Be a resident of the town of Beau Bassin -Rose Hill
- b. Have reached his / her 18th birthday at time of application
- c. Not already be a holder of any stall either in the town or in any other local authorities
- d. Undertake to work personally on the stall

(ii) Priority will be given to inhabitants of Beau Bassin Rose Hill.

(iii) In case the number of vacant stalls exceeds the number of eligible applications, the Council will then consider applications from the general public.

2. Mode of Application

(i) Each applicant may apply for a stall in more than one fair but successful applicant will be allocated only one stall at a market / fair.

(ii) Application forms duly filled in should be submitted with photocopies of the following documents:

- a. National Identity Card;
- b. Proof of address (CEB, CWA, Mauritius Telecom Bill) not more than three last months or any other relevant documents;
- c. Extract of Marriage Certificate (If applicable);
- d. Employment Registration Card (if any) ;

3. Closing Date

- (i) The Expression of Interest Application forms, duly filled and signed together with relevant document contained in a plain sealed envelope shall be addressed to the Chief Executive of the Municipal Council of Beau Bassin/Rose Hill, Town Hall, Rose Hill and should be deposited in the tender box, placed at the Registry of the Administration Department on **Monday 27th August 2018 by 14:00 hrs** (local time) at latest.
- (ii) **Expression of Interest sent by Fax/email will not be accepted.**
- (iii) **Expression of Interest received after the prescribed date and time will not be entertained.**
- (iv) **Incomplete, inadequate or inaccurate filling of application form may cause elimination from the exercise.**
- (v) **Application not made on the prescribed form will be rejected.**

4. Allocation of Stalls

- (i) Allocation of stalls for each market/fair would be made by drawing of lots on a date, time and place to be fixed by the Council in the presence of a Court Usher.
- (ii) All eligible applicants will be invited to attend the drawing of lots exercise at a time and place to be fixed by the Council and will be required to submit all original documents mentioned in 2(ii) on that day.

5. Signature of agreement/payment of relevant fees.

- (i) Successful applicants shall have to enter into a contract for a period not more than 3 years but may be expressly renewed for further periods not exceeding 3 years, on such terms and conditions as the Municipal Town Council may determine in each category.
- (ii) The successful applicant shall have to pay the yearly market fee and will also have to pay the appropriate trade fee on the date of signature of contract.
- (iii) The occupier shall abide by the Local Government Act 2011 and the Municipal Council of Beau Bassin Rose Hill Markets & Fairs Regulations, as amended or any other enactment.

6. The Municipal Council reserves the right to accept or reject the expression of interest or to annul the Expression of Interest process.
