2. **The Bidding document consists of:**

3. **Preparation of Bids**

The bids shall be made through the prescribed Bid form which the Bidder shall complete, sign and date in the spaces provided for that purpose.

4. **Submission of Bids**

Bidders shall submit the following documents enclosed in a sealed envelope:-

- (a) Bid Form duly filled and signed;
(b) Banker's Cheque (10% of the amount quoted);

The documents shall be deposited at the above address **on or before 09 April 2019 up to 14.30 hours (local time) at latest.**

Bids submitted after the prescribed date and time shall not be considered.

5. Late Bid Submission

Bids received after the prescribed time and date will not be considered.

6. Bid Bond

Bids should be accompanied by a Banker's Cheque **representing 10% of the amount quoted**, from a reputable bank drawn in favour of the Municipal Council of Beau Bassin-Rose Hill. **Please note that personal/company's cheque will not be accepted.**

7. Inspection

8. Confidentiality

All recipients of the Bidding documents (whether they submit a bid or not) shall treat the details of the documents as private and confidential.

9. Non Compliance with instructions

Any Bidder not complying with any of the instructions may find his offer rejected.

10. Validity of Bids

The bid submitted shall be valid for a period of 90 days.

Such prices shall remain effective and irrevocable during this period.

11. Other Conditions

- (i) The vehicle will be handed over to the successful bidder only after all transfer procedures at the level of the National Transport Authority are effected.
- (ii) Upon award of the Bid, payment should be effected in cash or by bank cheque.
- (iii) Duties, Taxes and VAT are not applicable.

12. The Municipal Council of Beau Bassin-Rose Hill reserves the right:-

- (a) To accept or reject any bid even the highest.
- (b) To annul the bidding process and reject all bids without thereby incurring.
 - (i) any liability towards any bidder, or
 - (ii) any obligation to inform any bidder of the grounds for the Council's action.
