1. The Municipal Council of Beau Bassin Rose Hill is inviting bids for the Renovation Works of Plaza Theatre (Phase III).
2. Qualifications requirements include:
 - (i) Bidders having the technical and financial capacity to mobilize key equipment and personnel for the contract consisting of major renovation works of the plaza theatre as described in the Bill of Quantities; and
 - (ii) Qualifying criteria mentioned in the Bidding Documents.
3. Bidding shall be conducted through **Open International Bidding** procedures according to the rules and regulations of Mauritius.
4. A complete set of the bidding documents in English may be downloaded free of charge from the Government Procurement Website **publicprocurement.govmu.org**
5. Any clarification sought by any bidder in respect of this procurement exercise shall be addressed in writing to the ‘Chief Executive, Municipal Council of Beau Bassin Rose Hill, Town Hall Rose Hill’ so as to reach the Municipal Council at least twenty one (21) days before the deadline for the submission of bids. The Public Body will reply to queries at latest 14 (Fourteen) days prior to submission of Bids.
6. Bids in sealed envelopes clearly marked ‘Renovation of Plaza Theatre (Phase III)’ and bearing the name and address of the bidder and **Reference Number CPB/31/2019** indicating the closing date, should be addressed to the Chief Executive, Central Procurement Board and deposited in the Bid Box or sent by courier service or registered post, so as to reach **The Chief Executive, Central Procurement Board, 1 Julius Nyerere Avenue (ex-Moka Road), 1st Floor, Social Security House, Rose Hill, Mauritius on 27 February 2020 up to 13.30hrs (local time) at latest.**
7. Electronic bidding shall not be permitted. Late bids will be rejected. Bids will be opened physically in the presence of the bidders/bidders’ representatives who choose to attend in person.
8. Bids shall be in accordance with provisions of the “Instruction to bidders” should be **valid for a period of 120 days** as from deadline for the submission of bids.

in the **Conference Room of the Central Procurement Board** as from **14.00hrs** (local time) on the same day of submission of bid.
